All stakes are open to all AKC pointing breeds. Amateur Gun Dog & Open Gun Dog are retrieving stakes, while all other stakes are non-retrieving.

Bitches in season may run in the last brace of the day only if entered in the last stake of the day ran on the course. AKC-approved tracking collars will be permitted. Tracking Collars will not be provided by the Host Club.

The Field Trial Committee reserves the right to cancel a stake with less than four entries.

Open Puppy (OP) stakes are open to all pointing breed dogs 6 months of age and under 15 months of age on Sept. 30th, 2022. OP will run **15**-minute braces, and **birds will not be released on course during this stake.**

Open Derby (OD) is a **non-retrieving** stake open to all pointing breed dogs 6 months of age and under 2 years of age on Sept. 30th, 2022. OD will run **20**-minute braces.

Open Gun Dog (OGD) is a **retrieving** stake open to all pointing breed dogs 6 months of age and over on Sept. 30th, 2022. OGD will run **30**-minute braces.

Amateur Gun Dog (AGD) is a **retrieving** stake open to all pointing breed dogs 6 months of age and over on Sept. 30th, 2022. AGD will run **30**-minute braces.

Amateur Gun Dog & Open Gun Dog are retrieving stakes. Dogs in contention will be called back for a retrieve. Blaze orange must be worn during call backs for retrieves.

Courses and Birds

All stakes are single course without a bird field. Chuckar, Pheasant, and/or Quail will be released in all stakes except Open Puppy. A blank cartridge will be fired on any gamebird contact on course in all stakes, except Open Puppy.

Dogs in contention will be called back for a retrieve.

Horseback handling and Scouting will not be permitted.

Prizes

Trophies or prizes will be awarded to first place in each stake. Standard AKC rosettes to all other placed dogs.

GROUNDS

- **Use Certified Weed-free Hay per land owner request.** Water for horses is available on the grounds. Bring your own drinking water for you and your dog(s). Overnight camping is permitted. Please pick up all dog droppings and scatter horse manure around.

Keep the parking area and your camp areas clean, fill in any holes, pits, tunnels, etc., that your dog or horse may have made.

(Leave No trace behind). No training/Hunting on grounds. Dogs (MUST) be on leash if not trialing.

If you are traveling North on Hwy 82/395 from Umatilla:

Take Exit #113, into Kennewick, after exiting and going down the hill Turn left onto W. Hildebrand Blvd., and a left onto South Ridge Blvd., and turn right onto Christenson Rd., go up & over Hwy 82. You will see us up ahead on the left. **PARK ONLY IN THE MOWED PARKING AREA.**

If you are traveling South on Hwy 395 out of Kennewick:

If you are traveling from Yakima on Hwy 82:
