AKC-approved tracking collars will be permitted. Tracking Collars will not be provided by the Host Club.

The Field Trial Committee reserves the right to cancel a stake with less than four entries.

**This Trial is being run under the flexible format option and the club reserves the right to rearrange the running of the stakes based on entry and course needs.**

## STAKES, SCHEDULE AND ENTRY FEES

### COURSE 1: Friday March 21<sup>st</sup>, 2025

**Open Puppy (OP)** stakes are open to all pointing breed dogs 6 months of age and under 15 months of age at the start of the stake. OP will run **15**-minute braces, and **birds will not be released on course.**

**Open Derby (OD)** is a **non-retrieving** stake open to all pointing breed dogs 6 months of age and under 2 years of age at the start of the stake. OD will run **20**-minute braces.

**Open Gun Dog (OGD)** is a **non-retrieving** stake open to all pointing breed dogs at least 6 months of age at the start of the stake. OGD will run **30**-minute braces.

**Amateur Limited Gun Dog (ALGD)** is a **non-retrieving** stake open to all pointing breed dogs at least 6 months of age at the start of the stake. ALGD will run **30**-minute braces. Refer to AKC Rules and Regulations for a complete description on Limited stakes.

**Amateur Puppy (AP)** stakes are open to all pointing breed dogs 6 months of age and under 15 months of age at the start of the stake. AP will run 15-minute braces, and **birds will not be released on course.**

**Amateur Gun Dog (AGD)** is a **retrieving** stake open to all pointing breed dogs at least 6 months of age at the start of the stake. AGD will run **30**-minute braces.

**Open Limited Gun Dog (OLGD)** is a **retrieving** stake open to all pointing breed dogs at least 6 months of age at the start of the stake. OLGD will run **30**-minute braces. Refer to AKC Rules and Regulations for a complete description on Limited stakes.

**Amateur Gun Dog is a retrieving stake.** Dogs in contention will be called back for a retrieve. Blaze orange must be worn during call backs for retrieves. **Open Limited Gun Dog is a retrieving stake.** First bird will be shot on course to demonstrate a retrieve. Blaze orange must be worn during the brace.

## Courses and Birds:

All stakes are single course without a bird field. Chukar, Pheasant, and/or Quail will be released in all stakes except Open Puppy and Amateur Puppy. Except where a retrieve is required, a blank cartridge will be fired on any bird contact in all stakes, except Open Puppy and Amateur Puppy.

## Scouting:

**Horseback Handling and Scouting will not be permitted in any stake.**

## Bitches in Season:

At the outset of the trial, it is not always clear which stake will conclude the running of dogs on any given day. We encourage participants to enter their in-season bitches in whichever stake(s) they desire and we will refund any entries for stakes entered that do not happen to conclude that day's events. The secretary still needs to be informed if in-season bitches are entered. We cannot accept entries after the closing date.

## Liability Release Form:

ALL PARTICIPANTS MUST SIGN THE ATTACHED LIABILITY RELEASE FORM IN ORDER TO BE ON THE TRIAL GROUNDS AND PARTICIPATE IN THE EVENT. PLEASE FILL OUT THE FORM (Page 4) AND RETURN IT WITH YOUR ENTRIES.

**Use of Grounds:**

All participants, guests & entries are accepted on the condition that the property owners, The Three Rivers Bird Dog Club, and its officers, officials, members and committee are released from liability for loss, damage or injury sustained by property, people, dogs, horses or ATV's in connection with or during the event.

**Use Certified Weed-free Hay per our land use agreement.** Water for horses is available at the site – ask Club Staff for assistance upon arrival. Bring your own drinking water for you and your dog(s). Weed Free Hay can be ordered in advance and purchased contact Bruce Dickey (509)-539-3343. Overnight camping is permitted. Please pick up all dog droppings and scatter horse manure around. Keep the parking area and your camp areas clean, fill in any holes, pits, tunnels, etc., that your dog or horse may have made. (leave No trace behind). **No training/Hunting on grounds.**

**Food and Beverages:**

Food and beverages will be available for a donation.

**Driving Directions:**

If you are traveling North on Hwy 82/395 from Umatilla:

Take Exit #113, into Kennewick, after exiting and going down the hill take the Ridgeline Drive Exit go around the round-a-bout to the left, onto Ridgeline Drive, go under overpass, take a left onto Southridge Blvd., go up the hill and turn right onto Christenson Rd., go up & over Hwy 82. You will see us up ahead on the left. **PARK ONLY IN THE MOWED PARKING AREA.**

If you are traveling South on Hwy 395 out of Kennewick:

Exit onto Ridgeline Dr. Then left onto Southridge Blvd., then right onto Christenson Rd., go over Hwy 82. You will see us up ahead on the left. **PARK ONLY IN THE MOWED PARKING AREA.**

If you are traveling from Yakima on Hwy 82:

Take Exit #113, into Kennewick, after exiting and going down the hill Take the Ridgeline Drive Exit onto Ridgeline Drive, take roundabout exit to the left onto Ridgeline Drive, go under overpass, take a left onto Southridge Blvd., go up the hill and turn right onto Christenson Rd., go up & over Hwy 82. AGREEMENT FOR ASSUMPTION OF RISK, INDEMNITY, AND RELEASE OF LIABILITY;

1. I \_\_\_\_\_ acknowledge that I have voluntarily applied to Three Rivers Bird Dog Club to participate in field trial or hunt test activities ("field events") sponsored by Three Rivers Bird Dog Club, its officers and members, to be held at Christenson Farms, in Kennewick Washington.
2. **ASSUMPTION OF RISK:** I am aware that field events are hazardous and can involve inherent risks and dangers, which could cause serious injury or death, including the following risks: the discharge by gunners and others of firearms with live ammunition; the presence of wild game either as the object of the trial or indigenous to the trial grounds; the use and presence of horses and dogs of unknown temperaments, degrees of training and control by their respective owners and handlers; and the use of motor vehicles on and off the field event grounds by various persons (and who may or may not have liability insurance). I understand that these risks and others are not specifically enumerated herein exist both during the actual field event and at other times before and after the event while the grounds are occupied by Three Rivers Bird Dog Club for purposes of conducting the field event over a period of one or more days to its conclusion. I am voluntarily participating in these activities with knowledge of the dangers involved, I hereby accept any and all risks of injury or death, and I verify my understanding and intent to do so by placing **my initials here:** \_\_\_\_\_ **X.**
