### If you are traveling from Yakima on Hwy 82:

Take Exit #113, into Kennewick, after exiting and going down the hill Turn left onto W. Hildebrand Blvd., and a left onto Southridge Blvd., and turn right onto Christenson Rd., go up & over Hwy 82. You will see us up ahead on the left. **PARK ONLY IN THE MOWED PARKING AREA.**
